The following amendment is made to Article IV of the BY-LAWS OF VIZCAYA MASTER HOMEOWNERS' ASSOCIATION, INC., recorded in Official Records Book 6090, Page 2455, et. seq., of the Public Records of Orange County, Florida (additions are indicated by underlining, deletions are indicated by strikethrough, and omitted but unaltered provisions are indicated by ellipses):

Section 3. Co-Owners, Spouses and Relatives. Co-Owners of a Residential Unit, spouses or relatives connected by blood or marriage, even if such spouses or relatives own separate Residential Units, may not serve on the Board of Directors at the same time.
